# Nonprofessional User Certification (UCert) UCert Data File Requirements and Naming Convention

### **File Structure**

Below are the specific Exhibit B data input file requirements and instructions that Vendors must comply with in order to successfully leverage UCert.

Input File Naming Convention: AccountName\_VendorInquiry.dat

File Type: Text Data file.

**Delimiter:** "|" pipe delimited file.

End of line: "\n" New Line

**Transmission:** FTP, SFTP

**Column Header:** Yes

### **Exhibit B Data Requirements**

Exhibit B Data requirements must be complied to avoid the Vendor Inquiry files from being rejected by the Tool. UCert will only run its process when files are structured as described.

#### **Exhibit B Detail File Formatting Tips**

- All thirty six columns (36) are mandatory, and must be provided in the order as listed above.
- The Column Name fields (including any underscores) must appear exactly as listed in the Column Name.
- Should your system not have data for any of the "Required" fields, simply leave blank. Hand keying N/A or Null may impact the results. Please provide the information as maintained in your system, otherwise leave blank.
- The file must be uploaded to MFT in pipe delimited (.dat) format.

### The following items will cause the file to fail or impact the results:

- The "AccountName" part of Exhibit B file name should not have any spaces/dashes/ underscores/punctuation marks. For example: ABC, LLC. should name the file as ABCLLC\_VendorInquiry.dat
- Password protecting the file.
- Reformatting or moving any of the column(s) order.
- Deleting the column if there are no records in your system for a particular column. Provide the information if maintained in your system, otherwise leave blank.
- Whitespaces or delimiters (|) at the end column thirty six, not just at the Column Name level but for the entire file itself.
