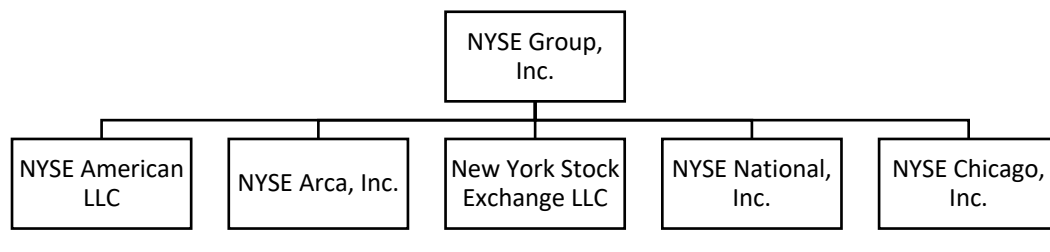

Participant NYSE American, LLC (“NYSE American”) – an indirect affiliate of Participant NYSE – is the network administrator for CTA and CQ Network B under the CT/CQ Plans. NYSE has assumed this responsibility on behalf of NYSE American.

Participants NYSE Arca, Inc. (“NYSE Arca”), NYSE Chicago, Inc. (“NYSE Chicago”), and NYSE National, Inc. (“NYSE Chicago”), are indirect affiliates of Participants NYSE and NYSE American.

The Plan Administrator directly performs the operational activities of CT/CQ data products, including contracting, usage reporting, entitlement reviews of CT/CQ data subscribers, and termination of data services. In addition, the Plan Administrator maintains the CTAPLAN.com website, hosts quarterly meetings of the Operating Committee, and provides data analysis as requested by the Operating Committee. The Plan Administrator also oversees finance, billing, tax, and audit services concerning CT/CQ participants and data vendors and subscribers.
